Summary

that the contract theory cannot accommodate all the economic relations created; Where economic relations have become require the intervention of several different legal centers in order to achieve them, and thus the need to search for a new type of contract that can contain all the relations that arise from such economic operations has emerged.

Attempts were numerous, as one of the main objectives pursued by the new amendment to the Law of Contracts, Obligations and Evidence, which was published in the Official Gazette of the French Republic in issue 0035 dated 11/2/2016¹ - was to achieve safety or legal stability through more clarification and simplification in the provisions of the contract law and making it more accessible to citizens

And it resulted in the proposal of a new type of contract, which is (the contract with multiple legal centers).

The aim of the research is to develop a new mechanism that allows the rooting of economic relations that require the intervention of more than two legal centers to achieve them, as the basis of the legal system for this new type of contracts must be established in order to achieve abstraction and generalization.

We apply this authentication to the financial lease contract (which is one of the non-traditional sources of medium and long-term investment financing, according to which the user (the lessee) transfers the right to use a specific asset owned by the lessor under a contractual agreement between the two parties in return for periodic payments for a specified period of time. The lessor The asset to be leased may have specific technical specifications and is used for specialized purposes. Lease it to the lessee, provided that the specifications of the required asset are determined by the lessee, and the resource is determined by the agreement of the lessor and the lessee.
